MOACAC Business Meeting 2019 Spring Conference April 1, 2019

Introductions by outgoing President, Earl Macam

- 1. NACAC Update (Mark Steinlage) Three topics of what is going on at NACAC—proposed membership model, DOJ update, proposals for governance restructuring. NACAC is proposing a revised membership model in 2019. NACAC has become stagnant in its growth and believes the changes to the membership model will increase membership. Realizing that one size does not fit all and the new model creates a hybrid model containing both institutional and individual membership options. It will provide Institutional, Associate, and Individual memberships for which members can choose to join NACAC. Proposed schedule of dues has also been drafted but are not set at this time. Final decisions will be made by the board once they hear feedback from membership. Changes are proposed to create a more solid future for NACAC and work to serve a more diverse population. Regarding the DOJ investigation, there has been some progression. The DOJ states there are 3 major issues that restrict trade and should be changed regarding recruiting. Specifically, the elements of the CEPP under scrutiny are the ones that:
 - a. Prohibit colleges from offering Early Decision applicants exclusive incentives not available to students applying under other admission plans [Section II.A.3.a.vi of the CEPP];
 - b. Limit colleges' ability to recruit students beyond the May 1 National Candidates Reply Date, including limits on the recruitment of students who already have committed to attending a college; [preface of Section II.B. and II.B.5 of the CEPP] and
 - c. Limit the recruitment of transfer students **who** may have been in a previous applicant or prospect pool or may already be enrolled in a college. [Section II.D.5. of the CEPP]

NACAC has been as responsible as possible, but also believes the CEPP has been key in creating fairness in recruiting students and protecting students in the admission process. There is the possibility of a special session in the event there is a change in CEPP based on findings by DOJ. In regards to changes in governance, this is happening because members are saying they want more say and more transparency. Technology has made it possible for changes to happen to make that possible including voting and other communications. No changes are final at this time.

The Ad Hoc Committee on Governance proposals include the following:

- "Enable the Assembly to elect national officers via online voting, to conduct the vote at least two weeks prior to the national conference."
- "Permit the Board of Directors to allow up to five appointed board members (an increase from the current limit of three) to allow greater flexibility to address organizational issues as needed."
- "Change qualifications for Board service and expand pool of eligible candidates to "voting members in good standing for five years."
- "Remove language specifying the size of committees from bylaws AND reduce the overall number of standing committees other than those outlined specifically in the bylaws in favor of ad-hoc and advisory committees with specific assignments and short terms of service. Increase the number of members on the Governance and Nominating Committee."
- "Convene the Assembly on Thursday morning of the National Conference."
- "Convene the Annual Membership Meeting on Friday of the Annual Conference."

Mark also recognized Steve Held and Nikki Hostnik and the rest of the conference planning committee for preparations this year. Recognized Rob Lundien for service to professional development, Charlie Hungerford as incoming president and Earl Macam as outgoing president.

- 4. <u>Treasurers Report</u> (Liz Majors) Our 3rd year of regional college fairs has proven to be very successful as a business model. We will be meeting at our retreat in June to see how we can invest back into our membership as well as fiscally invest to grow our assets so we can grow as an association.
- 5. <u>Membership Report</u> (Lizzi Delaney) We currently have 724 members. Memberships are represented from not only MO, but across the US. Over 700 members is excellent number for an affiliate to have.

- Professional Development Report (Gwen Tohill-Macam and Erin Stein) There will be 3 CUBES at the end of August in KC, STL, and mid-MO. CCI will be held in October in Rockhurst. Copies are on the table with exact dates.
- 8. <u>IAS Report</u> (Ashley Beck) STL IAS Conference is April 28th in conjunction with Maryville Fair. The mid-MO conference will be held on June 15 at Lincoln University. We will announce Braxton Rethwisch scholarship winners later in program.

- 11. <u>Government Relations</u> (Kyle Strothmann) Some board members traveled to DC for advocacy day. Kyle also chairs the international Initiative. Congressmen did not meet with us while we were there. There was no response from them when we inquired. As far as international initiatives is concerned, we are looking at resources to best promote Missouri to international students.
